All Assistant Commandants and Officers Commanding are directed to verify the date of birth of all personnel working under them with reference to their small service books and report omission / error, if any noticed, to this office immediately. If any officer is received on transfer from other units their name and rank should also be reported to this office for verification and to avoid omission. The officers concerned will be held responsible for the omission, if any noticed later.

Copy of this order should be served on each retiring person on proper acknowledgement and they may be instructed to submit their formal application for pension in Duplicate (2 copies of pension book, 2 attested copies of descriptive roll and identification particulars, 2 copies of application for commutation of pension in form D, 2 permanent address slip showing address after retirement etc.) before six months from the date of retirement.
