report immediately to this office if there any omissions in the list at Para 1 above.

4. The Unit Officers are directed to advise the employees due to retire to prepare their pension papers, GPF Closure Applications, Application in Form III with pass book(Duly attested if possible) for GIS claim, Application addressed to District Insurance Officer , Pass book (duly attested if possible), Policy certificate for SLI claim sufficiently early and forward to this office well in advance.

A copy of this order should be given to each Officer who are retiring on superannuation during the year 2018.
