As per the Special Rules for the Kerala Police Service read as (1) above, appointments to the post of Reserve Inspectors in the District Armed Reserves shall be made by promotion and appointment by transfer of Reserve Sub Inspectors of District Armed Reserves of the Kerala Police Subordinate Service. For this purpose, select Lists are being prepared by the Departmental Promotion Committee as per Rule 28(b)(i) of KS&SSRs. Accordingly, the select lists have been prepared by the Departmental Promotion Committee (Lower) based on the finalized Seniority List of Reserve Sub Inspectors as on 01/01/1996 published as per the PHQ proceedings No.L5/83024/98 dtd: 01/08/2001.

In compliance with the Judgments of the Hon'ble High Court of Kerala and the Hon'ble Supreme Court of India read as 4 to 9 above, seniority position in the finalized seniority list of Reserve Sub Inspectors as on 01/01/1996 and 01/01/2002 have been modified. As per Rule 28(b)(i)(7) of Part II KS&SSRs, persons selected for inclusion in the Select list shall be ranked in the Select List according to their seniority in the feeder category. Accordingly, the select lists of Reserve Sub Inspectors fit for promotion as Reserve Inspectors for the years 2000 to 2007 have been modified by the Departmental Promotion Committee (Lower) based on the modified seniority list of Reserve Sub Inspectors in compliance with the judgments read as (4) to (9) above. Regularization/Notional promotion as Reserve Inspectors from 01/02/2000 onwards has also been modified and ordered as per the DGO read as 10 above.

In the above circumstances, the seniority position of Reserve Inspectors from SI.No.20 onwards in the finalized Seniority list of RIs as on 01/01/2005 published as per the order read as (2) above, required revision. Accordingly, the provisional seniority list of Reserve Inspectors as on 01/04/2011, in supersession of all previous seniority lists, is published herewith. This Seniority List will be subjected to the disposal of all the Writ Petitions pending before the Hon'ble Courts in the matter.

All are requested to submit objections, if any, against the provisional Seniority list within 15 days from the date of publication of the same. Personal hearing will be allowed to those who submit request in writing within the time limit mentioned above.

If no objection is received within the prescribed time limit, the provisional seniority list will be finalized on the presumption that there is no objection against the same.
