PROCEEDINGS OF THE DEPUTY INSPECTOR GENERAL OF POLICE
RANGE OFFICE, THIRUVANANTHAPURAM

Sub : Provisional Seniority List of Armourer Havildars/ Head Constables of
Tvpmm Range as on 01/01/2016- Finalised- Order issued

A Provisional Seniority list of Armourer Havildars/Head Constables of Thiruvananthapuram Range as on 01/01/2016 was published vide this office order read as 1st paper above. The Unit heads concerned in Thiruvananthapuram Range were requested to circulate the provisional seniority list among all the concerned forthwith and to forward complaints/suggestions, if any received against the provisional list within 10 days from the date of publishing the list.

As per this office order read as 3rd paper above, the regularisation of Provisional Promotion of Armourer Police Constables to the rank of Armourer Head Constables/Havildars of Thiruvananthapuram Range is revised, since it is found that some anomalies were crept in the criteria adopted for the regularisation of Armourer personnel done in Thiruvananthapuram Range, vide this office order read as 2nd paper above. The revised regularisation of promotion of Armourer PCs to the cadre of Armourer HCs/Havildars is done, based on the exact date of occurrence of vacancies and they are assigned eligible seniority in the cadre of Armourer Head Constables, as per existing rules, as shown below.

Some complaints are received against the Provisional Seniority list within the stipulated period, as detailed below and all of the have been verified.

1) Sri.G.Sureshkumar, Armourer SCPO 3103, AR, Pathanamthitta/ Sri.Jayakumar.J, Armourer Hav 4000, KAP III, Adoor

The petitioners has said that they have joined SAP coming under Tvpmm Range Armourer Police Constable on 28/05/2001 by Inter district transfer from KAP II Bn and MSP, respectively. It is alleged Sri.Shajahan who had worked as junior to the petitioner while in KAP III Bn has been assigned as senior in the provisional seniority list of Armourer HCs of Tvpmm Range as on 01/01/2016. Sri.Jayakumar.J, Armourer Havildar 4000 has also requested that his qualification in the provisional seniority list may be added as VHSC & ITI.

The petitions have been examined in detail and the matter is related to the seniority of the petitioners in the cadre of Armourer Police Constable of Tvpmm Range. It is found that, based on a complaint filed by Sri.Sureshkumar, Armourer PC Q 5957 (SCPO 3103) before the Police Establishment Board on 22/08/2011, a decision was taken by the Board on 28/11/2011 to maintain the seniority of Sri.Shajahan in the cadre of Armourer PC w.e.f 28/05/2001 ie.just above the petitioners, as in the modified seniority list of Armourer PCs of Tvpmm Range as on 01/08/2001, published vide Order No.A5/3661/2009 TR dated 01/07/2010. As such the modified seniority list of Armourer PCs of Tvpmm Range



as on 01/08/2001 was revised and published vide this office Order No.A5/3661/2009 TR Dated 16/12/2011. Hence the request of the petitioners cannot be considered and devoid of merits.

Necessary changes with regard to the qualification of Sri.Jayakumar.J, Armourer Havildar 4000, as requested has been made in the finalised seniority list.

2) Sri.P.Satheesh Kumar, Armourer SCPO 1705, AR, Tvpm City

The petitioner has stated that he had passed written test, practical test & interview for the appointment as Armourer Police Constable in Thiruvananthapuram City on 08/05/1998. It is said that the medical test for the appointment was delayed by 19 months, held on 23/12/1999, on account of an error the Govt Order concerned in this regard, wherein the trade 'fitter' was mentioned as 'feeder'. It is said that, in compliance of the order of the Hon'ble High Court of Kerala in OP No.16937/1999 filed by him, he got appointment as Armourer PC on 23/12/1999. It is also said that thereafter he had submitted several petitions to the authorities to count the said 19 months for seniority & other service benefits and finally he has approached the Hon'ble KAT, Tvpm by filing OA No.2242/2015. It is further said that, challenging the decision taken by the authorities which is not decided in his favour, he has filed OA No.2681/2016 before the Hon'ble KAT and the same is pending before the Tribunal. It is alleged that he is entitled to get 3rd place in the provisional seniority list and requested to take necessary action in this regard.

The petition has been examined in detail and found that, as per the judgement dated 04/05/2016 in OA No.2242/2015 filed by Sri.Satheesh Kumar.P, Armourer HC 1705, AR Tvpm City, the Hon'ble Kerala Administrative Tribunal, Thiruvananthapuram has ordered by disposing the Original Application with a direction to this office (3rd respondent ie, IGP, Tvpm Range) to take a decision on the representation submitted by the petitioner before the Tribunal after hearing the applicant and anybody else affected, within a period of two months from the date of receipt of a certified copy of this order.

As such hearing of the applicant and the affected parties were held in this office 07/07/2016 and 07/09/2016. Based on the hearing and further verification as per the existing rules, it was decided and informed that Sri.Satheeshkumar.P, Armourer HC T 1705, AR, Thiruvananthapuram City can be assigned seniority in the category of Armourer Police Constable w.e.f the date of order of his appointment in Government Service only. The petitioner has been assigned eligible seniority in the cadre of Armourer Police Constable, as per rules. Hence the petition preferred by the Sri.Satheesh Kumar, SCPO 1705 against the provisional seniority list deserves no merits.

3) Sri.Sabu.S.S, Armourer HC T 4252, Police Chief Store, PHQ, Tvpm

The petitioner has raised contention that his date of birth and qualification are omitted in the provisional seniority list.

The same has been verified and the date of birth & qualification of the petitioner has been included in the finalised seniority list.

4) Sri.Jibi.J, Armourer HC 5891, AR, Kollam

The petitioner has raised objection that his General Number is wrongly entered in the provisional seniority list as Q 6868 and requested to correct his General Number as Q 5891.

The same has been verified and necessary changes in this regard are made in the finalised seniority list.

5) Sri.Vinayakumar.P, Armourer HC N 2904, AR, Pathanamthitta

The petitioner has raised contention that he is given date of regularisation of his promotion as 21/11/2013 and said that that he is eligible for regularisation on the vacancy Sri.Nazeer Khan, ASI.

The same has been verified and necessary changes are made in the provisional seniority list in this regard.



6) Sri.Shajahan.A, Armourer Hav. 8358, SAP, Tvpm.


The petitioner has said that he is given date of regularisation of promotion as Armourer Havildar w.f 01/04/2009 ie. the vacancy of Sri.Baburajan HCT 8861 promoted as ASI. It is alleged that he is eligible for regularisation of promotion w.e.f 12/09/2007 ie, regularisation of his promotion as ASI.

The petition has been examined and found that some anomalies were crept in the criteria adopted for the regularisation of Armourer PCs as Armourer HCs/Havildars done in Thiruvananthapuram Range, vide this office Order read as 2nd paper above. Hence the regularisation of Provisional Promotion of Armourer Police Constables to the rank of Amourer Head Constables/ Havildars of Thiruvananthapuram Range is revised, based on exact date of occurrence of vacancies, as per this office Order read as 3rd paper above. Based on the same, the petition preferred by Sri.Shajahan.A, Armourer Hav 8358 deserves no merits.

In the above circumstances, the provisional Seniority list of Armourer Havildars/Head Constables of Thiruvananthapuram Range as on 01/01/2016, published vide this office order read as 1st paper above is hereby finalised with the changes as necessary and published as in the Annexure appended herewith. The finalisation of the seniority list is subject to the disposal of OP/OA/Writ Petitions, if any, pending before the Hon'ble Courts/KAT and Govt directions.

The unit heads concerned in Thiruvananthapuram Range will arrange to circulate the finalised seniority list among all the concerned forthwith.

This office order read as 2nd paper above is modified to this extent.
