A provisional year wise seniority list of Reserve Sub Inspectors of Police in Thiruvananthapuram Range as on 01/01/2015 was published vide this office order read as 1st paper above, in continuation of the year wise seniority lists of Reserve Sub Inspectors of Police in Thiruvananthapuram Range as on 01/01/2012, published vide this office order read as 2nd paper above. The above lists were prepared based on the revised Range wise Seniority list of Reserve Sub Inspectors of Police in Thiruvananthapuram Range as on 01/04/2010, published vide order read as 5th paper above.

The unit heads concerned in Thiruvananthapuram Range were requested to circulate the seniority list among all the concerned forthwith and forward complaints/ suggestions, if any received against the provisional list within 10 days from the date of publishing the list. Some complaints are received against the provisional seniority list within the stipulated period, as detailed below and all of the have been verified.

**1) Sri.Asokan.C, RSI T 6494, AR, Thiruvananthapuram City**

The petitioner has alleged that he was promoted as RSI as per TRO No.02/2011 dated 06/01/2011. It is said that his position in the seniority list of RSI has already been re fixed in between Sri.Syed Abdul Hashim (T 6487) and Sri.Vijayaraghavan (T 6506), as per TRO No.110/2014 dated 13/10/2014. Hence the petitioner has requested steps to re assign his seniority in the provisional seniority list of RSIs of Police of Tvpm Range as on 01/01/2015.

The claim of the petitioner has been verified with this office records and found that Sri.Asokan.C, RSI T 6494, AR, Tvpm City has been given retrospective promotion as RSI of Police as per TRO No.110/2014 dated 13/10/2014 and his position in the Select list of ASIs (AR) fit for promotion as RSIs for the year 2008 has been re fixed in between Sri.Syed Abdul Hashim, RSI T 6487 and Sri.Vijayaraghavan, RSI T 6506. It is also found that TRO No.02/2011 dated 06/01/2011, by which the petitioner has been promoted as RSI of Police was also modified to this extent.

Accordingly, the seniority position of Sri.Asokan.C, RSI T 6494, AR, Tvpm City in the Seniority list of RSIs of Police of Thiruvananthapuram Range as on 01/01/2015 has been re fixed in between Sri.Syed Abdul Hashim, RSI T 6487 and Sri.Vijayaraghavan, T

6506, as SI No.16 and necessary changes have been made in the seniority lists of RSI of Police of Thiruvananthapuram Range.

**2) S.Suresh Kumar, RSI, AR, Thiruvananthapuram City**

The petitioner has raised contention that he was promoted as RSI in the year 2011 and alleged that he is not included in the provisional seniority list of RSIs of Police of Thiruvananthapuram Range as on 01/01/2015.

The petition has been verified and found that the provisional seniority list of RSIs of Police as on 01/01/2015 is prepared upto the promotion of Sri.Sathyaseelan, RSI N 1287 and the seniority of Sri.S.Suresh Kumar, RSI comes next to Sri.Sathyaseelan, RSI, the petitioner cannot be included in the Seniority list of RSIs of Police as on 01/01/2015.

In the above circumstances, the provisional seniority list of RSIs of Police of Thiruvananthapuram Range as on 01/01/2015, published vide this office order read as 1st paper above is hereby finalised with the changes as necessary and published as in the Annexures appended herewith. The finalisation of the seniority list is subject to the disposal of OP/OA/Writ Petitions, if any, pending before the Hon'ble Courts/KAT and Govt directions.

The unit heads concerned in Thiruvananthapuram Range will arrange to circulate the finalised seniority list among all the concerned.
