Their contention is that they have been recruited as SI of Police(GE) in the year 2007 & 2009 as per the KPSC advice. Accordingly, they had undergone training and successfully completed basic training and practical training. And they have been appointed as SHOs in various districts. But, in the provisional Seniority List, their name has not been included.

The petitions have been examined in detail and found eligible for inclusion in the List. Out of the 5 petitioners, Sri. R.Roj, Sub Inspector of Police(GE), Railway PS, Thiruvananthapuram is included in the Seniority List for the year 2007 as SL No. 1902 as per the KPSC Advice Letter No. RIC(3) /36530/2006/GW dated 02.07.2007 and appropriate position in the subsequent years. And the petitioners as SL No. 2 to 5 are included in the Seniority List for the year 2009 as SL No. 1792 to 1795 as per the Advice letter No. RIC(3) 36530/2006/GW dated 27.10.2009.

**Sri. Honey K Das, Sub Inspector of Police(GE)** who was not included in the Provisional Seniority List for the year 2009 is also included in this Seniority List for the year 2009 as SL No. 1790 as he is found eligible as per the Advice Letter No.RIC(3) 36530/2006/GW dated 07.04.2009.

#### **6. Sri.K.T.Premajan, SI of Police(Rtd) , Thrissur Range**

The petition of Sri. K.T.Premajan, SI(Rtd), is that his name is not included in the Provisional Seniority List. Remarks on the petition has been obtained from the Inspector General of Police, Thrissur Range vide reference cited 7th and considering the remarks the petitioner Sri. They have represented that, certain Juniors of them as per the Finalized Seniority List of Sub Inspectors of Police(GE) issued vide Order No. E2-27772/2014/PHQ dated 04-11-2016 are ranked above them in the Provisional Seniority List of Sub Inspectors of Police(GE) for the year 2007. In the representations, they have now requested to assign Seniority in the Rank of Sub Inspector (GE) reckoning the date of Advice as RSI in the year 2006.

Their requests cannot be considered. As per the GO (P) No. 268/2010/Home dated 10-12-2010 and PHQ Circular No. 01/2013, it is clearly specified that no direct RSI already in service as on 01.04.2010 who opt to join KCP will have claim for any Seniority in the KCP cadre from any date earlier than the date on which two years would have elapsed after his date of completion of basic and practical training or 01.04.2010, whichever is earlier. Any direct recruit RHC or RASI or RSI joining service after 01.04.2010 will be deemed to have joined KCP cadre with seniority with effect from 01.04.2010 AN or the date of KPSC advice, whichever is later. Hence, requests deserves no merits and therefore rejected.



**The name of the following Sub Inspectors of Police** are included in the provisional Seniority list based on the Advice List received from KPSC, but as they did not join as Sub Inspector of Police (GE) in this Department. The existing seniority position of **Sri. Lijo Joseph, Sub Inspector of Police**, is SL No. 1261 as per the finalized Seniority list for the year 2006 published vide PHQ Order No. E2-24772/2014 dated 04.11.2016.

Sri. Lijo Joseph, Sub Inspector of Police was provisionally appointed as SI(GE) and completed training on 06-10-2006 AN and was allotted to Kochi City. During the period of probation, he had availed 5 years LWA with effect from 20.08.2017 AN vide GO(RT) No. 2102/2007/Home dated 04.08.2007 and later he joined duty on 15.06.2011 FN after cancelling the unavailed portion of leave. Hence, as per GO(P) 780/1983 Fin dated 16-12-1983 clause(V), he was deemed to have entered in service as a new entrant on 15.06.2011 FN and placed on probation afresh for a period of 2 year on duty within a continuous period of 3 years with effect from 15.06.2011 FN.

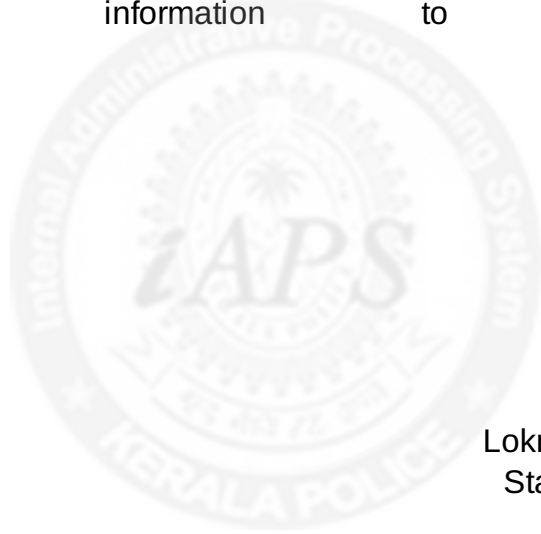


As such, the name of Sri. Lijo Joseph, Sub Inspector of Police had been excluded from the Seniority List for the year 2006, and his seniority in the Rank of Sub Inspector of Police will be assigned with effect from **15.06.2011** ie, with effect from the date on which he was admitted in service as a new entrant as stated in the PHQ Order No. E2-24772/2014 dated 02-05-2017.

The provisional Seniority List of sub Inspectors of Police (GE) for the period from 01.01.2007 to 31.03.2010 is hereby finalized with the above mentioned modifications.

The OA No.671/2015 filed by Sri. Vidhyadharan, Inspector of Police Pamba , OA No. 389/2016 filed by Sri. K. Balaji, Inspector of Police , CBCID, EOW-1, Kollam , OA.No. 419/2016 filed by Sri. Rajesh Kumar.R, Sub Inspector of Police & others, OA(EKM) No. 791 of 2016 by Sri.R. Vijayan, Inspector of Police, CBCID- EOW-1, Thiruvananthapuram and OA No. 2356 of 2016 filed by Sri.R. Vijayan, Inspector of Police and others relating to the seniority in the Rank of SI(GE) are pending before the Kerala Administrative Tribunal. Hence, the Statewide Combined Seniority List of Sub Inspectors of Police(GE) for the period from 01.01.2007 to 31.03.2010 is subject to the final disposal of the above pending OAs.
