Sub :- Estt – Revision of seniority of Promotee SIs of Thrissur Range in the Statewide Combined Seniority list of Sub Inspectors of Police (GE) as on 31.12.2003 – Modified - Finalised – Orders issued.

**Order No. E2/66255/2010 Dated 02/12/2013**

A Statewide Combined Seniority list of Sub Inspector of Police (General Executive Branch) as on 19.03.2003 was finalized and published vide reference 1<sup>st</sup> cited, and the seniority list of SI (GE) for the period upto 31.12.2003 was published in continuation of the Statewide combined seniority list of SI (GE) as on 19.03.2003 by consolidating the seniority list of Sub Inspector of Police (GE) published from the respective ranges, and by including the directly recruited SIs reckoning their effective date of advice by KPSC. Against the seniority list 1<sup>st</sup> cited, certain SIs of Thrissur Range has filed WP (c) No. 11047/2011 before the Hon'ble High Court of Kerala and the same was disposed vide reference 2<sup>nd</sup> cited with direction to the Government to consider and pass orders on the representation of the petitioner. In compliance of the Judgment, Government vide reference 3<sup>rd</sup> cited, have directed the State Police Chief to examine the representation of the petitioners and revise the Statewide seniority list of SI (GE) by inducting the name of the petitioners in their appropriate place after serving notice to the affected parties, if eligible.

In order to comply the Government order 3<sup>rd</sup> cited, instructions were issued to Inspector General of Police, Thrissur Range to examine the representations of the

petitioners in WP (c) No. 11047/2011, as the petitioners belongs to Thrissur Range. On scrutiny of the seniority lists of SIs of Thrissur Range it was found by Inspector General of Police, Thrissur Range that certain vacancies of SIs were not reckoned for regularizing the promotion of SIs. Accordingly the regularization of promotion of SIs were revised. Pursuant to this, 14 more SIs were found eligible for inclusion in the seniority list of SIs as on 31.12.03. Accordingly the seniority list of SIs as on 31.12.03 of Thrissur Range has been revised by inducting 14 SIs including the petitioners in WP (c) No. 11047/2011 and finalized vide order 5<sup>th</sup> cited.

As the date of regularization of SIs of Thrissur Range has been altered and 14 more SIs were included in the seniority list of Thrissur Range, the Statewide combined seniority list of SIs published vide ref. 4<sup>th</sup> cited also required to be revised. Accordingly the Statewide combined seniority list of SIs as on 31.12.03 was provisionally revised vide order 6<sup>th</sup> cited and circulated among all concerned calling for objections if any against the list.

The following officers have submitted representations against the provisional Statewide seniority list 6<sup>th</sup> cited.

All the representations received have been examined in detail with reference to the connected records, relevant provisions / rules of KS & SSRs and remarks furnished by Inspector General of Police, Thrissur Range. IGP, Thrissur Range vide letter 7<sup>th</sup> cited has reported that the promotion of the petitioners 1 to 3 to the rank of Sub Inspector of Police are regularised on 1.07.03, 1.08.03, 1.09.03 respectively. Accordingly they are eligible for ranking as SI in the seniority list for the year 2003. The promotion of Sri. K.V.

Ramachandran (*ie; petitioner 4*) as Sub Inspector of Police is regularized w.e.f., 1.08.04 and he is eligible for seniority in the year 2004 only. Replies in this regard have been given to all the petitioners vide reference 8<sup>th</sup> cited.

As such the seniority list of Sub Inspectors of Police (GE) as on 31.12.03 published vide order 4<sup>th</sup> cited is modified to this extent.
