TSRO NO.285/2016

In pursuant to the direction of the State Police Chief, Kerala vide letter No.E2/24772/2014/PHQ dated 04/2016, seniority list of Sub Inspectors of Police (GE) in respect of Thrissur Range for the period from 1996 to 2006 has been revised as per Order No :TSRO. NO 86/16 (A1-15333/2013/TSR Dated. 07-05-2016) adopting 1:1 ratio between directly recruited SIs and promote SIs.Then the Statewide seniority list of Sub Inspectors of Police (GE) upto 2006 has also been published vide PHQ order cited 3rd in the reference.In continuation to that,now direction has been issued as per the PHQ message referred 1st above, to prepare the year wise Seniority list of Sub Inspectors of Police (GE) for the period from 01-01-2007 to 31-12-2015. A clarification on the matter of utilizing 50% of the posts of RSIs shifted to Kerala Civil Police Cadre consequent on the integration of District Armed Reserve and local Police into a single unit called Kerala Civil Police Cadre vide GO(P) No.268/2010/Home dated 10.12.2010 for regularization has been sought from PHQ. As per the reference 2nd cited above, the State Police Chief, Kerala clarified that, 50% of the Shifted posts can not be taken for regularizing the promote Sub Inspectors of Police.

As per the reference 3rd cited above, the State Police Chief, distributed 78 posts of Sub Inspectors of Police (39 wef 01.07.12 and 39 wef 01.04.13) to Thrissur Range as stagnation quota for promote SIs. It was also clarified that these posts can be utilized for



regularization of promote in the rank of Sub Inspectors of Police. 41 posts of SIs in special units were also allotted to this range from Police Headquarters vide E2/91359/07 dated 18.04.09 for regularization of promote SIs from 01.01.2000 onwards. As such year wise regularization of promote SIs are done as shown below .

NO 86/16 (A1-15333/2013/TSR Dated. 07-05-2016). All the officers who got promotion to the cadre of Sub Inspectors of Police on regular line of promotion from approved select lists by convening Departmental Promotion Board have been included in the seniority list. The officers who got regular promotion as Sub Inspectors of Police as per the provisions contained in the order vide GO(MS) No.37/2015/Home dated 26.02.2015 are not included in the seniority lists. The District Police Chiefs / Superintendents of Police of Special Units will circulate the list among the concerned under proper acknowledgement. Omissions, Objections, Suggestions, errors etc if any received against the list should reach to this office with specific remarks within



10 days. The belated representations will not be entertained and the list will be finalized accordingly.
