In pursuance of the direction of the State Police Chief, Kerala to prepare year wise Seniority list of Sub Inspectors of Police (GE) vide reference 1st cited, a provisional year wise Seniority list of Sub Inspectors of Police (GE) for the period from 01-01-2007 to 01.01.14 has been published vide reference 2nd cited above. The provisional list has been circulated among all the concerned through the District Police Chiefs and the unit heads concerned inviting objections/representations etc within 10 days from the date of publication of the list. The provisional list has been published in the official website of Kerala Police also. The following officers have submitted representations against the provisional seniority list of SIs(GE) published vide reference 2n cited.

The representations of the above officer's serial No.1 to 8 are common in nature. They have represented that they are seniors as per the Range Seniority list of SCPOs published vide A1/14571/2011 KR dated 16.12.2013 and not included in the seniority lists of SIs (GE) published vide reference 2nd cited above. But their juniors (as per A1/14571/11KR dated 16.12.2013) were included in the seniority list of SIs (GE) published vide A1/16585/2016 KR dated 02.12.2016 and requested to take steps to give them regular promotion as per A1/14571/11KR dated 16.12.2013.

The implementation of the seniority list of Senior Civil Police Officers published vide A1/14571/11KR dated 16.12.2013 has been temporarily stopped as per the direction of the Government vide letter No.117304/A1/13/Home dated 26.12.2013. Hence the petitioners request for regular promotion as per the seniority list vide A1/14571/11KR dated 16.12.2013 could not be considered at present. The seniority lists of Sub Inspectors of Police has been prepared as per the direction of the State Police Chief, Kerala vide reference 1st cited above. All officers who got promotion as Sub Inspector of Police from the approved select lists of Assistant Sub Inspector of Police fit for promotion as Sub Inspector of Police have been included in the provisional seniority lists of SIs(GE) published vide reference 2nd cited above. The petitioners are still continue as Assistant Sub Inspectors of Police. They are not included in the approved select lists of Assistant Sub Inspector of Police fit for promotion as Sub Inspector of Police and promoted to the cadre of Sub Inspector of Police against regular vacancies. They are not eligible to be included in the seniority lists. Hence their representation cannot be considered.



9 & 10 Raveendra Nathan N K, W 587 and Muraleedharan P, W 486 :- Their representations are common in nature. They represented that due to the non-implementation the Government order vide GO(P) No.33/89/Home dated 10.03.1989, they lost their eligible seniority. The provisional seniority lists of SIs(GE) was published without considering the the Government order vide GO(P) No.33/89/Home dated 10.03.1989. Sri Raveendra Nathan N K, W 587 represented that GL No. D 4559 was erroneously added with his original GI No. W 587.

The implementation of the seniority list of Senior Civil Police Officers published vide A1/14571/11KR dated 16.12.2013 (prepared as per rule GO(P) No.33/89/Home dated 10.03.1989) has been temporarily stopped as per the direction of the Government vide letter No.117304/A1/13/Home dated 26.12.2013. Hence the petitioner's requests for regular promotion as per the seniority list vide A1/14571/11 KR dated 16.12.2013 could not be considered at present. The General Number is corrected as W 587.

SI 11, Balakrishnan T T, D 5512, District Special Branch, Kozhikode City :- Represented that the date of regularization of Sri Jayachandran, D 2790 serial No.1 in the seniority list is shown as 01.05.01 and the date of regularization of Sri K G Roy, D 5506 is shown as 01.03.04. The regularization against the vacancies which arose during period 2002 and 2003 are not taken into account and requested to regularize him during the year of his promotion of 2002.

All the vacancies eligible for the promoted SIs for the period from 2002 and 2003 were taken into consideration for regularization. It can be verified in the seniority lists of SIs(GE) as on 01.01.03 and 01.01.04 published vide IGO No.129/2016 KR dated 04.05.2016 (A1/5626/2016KR). The name of those SIs(GE) who got regularization during the period 2002 and 2003 and retired subsequently would not be included in the seniority lists and the vacancies occurred due to their retirement will be taken for regularization of promoted SIs. Hence the representation of Sri Balakrishnan T T, D 5512 could not be



considered.

Under the circumstances the provisional seniority lists of Sub Inspectors of Police published vide reference 2nd cited is hereby finalized as stated above. The seniority lists are appended herewith. The District Police Chiefs/Superintendents of Police and the concerned unit heads will circulate the list among the concerned.
